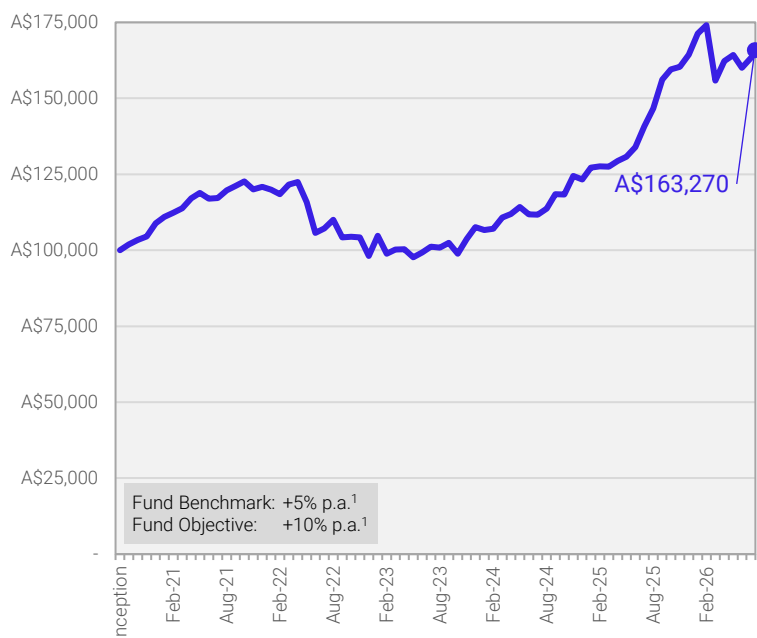

STRATEGY OVERVIEW & CONTRIBUTION TO RETURNS

The Baza Special Opportunities Fund (the Fund) invests in ASX-listed companies that exhibit deep value characteristics, and special situations. The Fund's portfolio has a different cadence to the broader equity market, seeking to deliver strong absolute returns, capital preservation, low beta relative to the S&P/ASX 200 and low volatility.

Deep value | 57% portfolio exposure | +0.6% contribution to returns for month¹

COMMENTARY

The Fund returned +2.0% in July, performing in line with the S&P/ASX 200 Accumulation Index (+2.3%), and outperforming the S&P/ASX Small Ordinaries (-3.2%) and S&P/ASX Emerging Companies (-5.1%) Accumulation Indices.

The Fund has returned +17% p.a. with a beta of 0.61 and volatility of 11% in the last 3 years.

The largest deep value contributors were investment company, Touch Ventures (TVL, +0.4%), and cybersecurity firm, Senetas (SEN, +0.4%).

TVL currently trades at 0.54x net tangible asset backing. TVL remains well capitalised and continues to carefully invest in globally scalable, mature venture opportunities at the rate of around 1 investment per 6-month period.

SEN is a leader in the growing segment of cybersecurity that relates to threats from quantum computing. SEN has a market capitalisation of ~A\$50M, which is largely accounted for by its cash position and shareholding in Menlo Security. The profitable operating business of SEN is attributed negligible market value based on its current share price.

The strong positive contribution from special situations was dominated by fundraising investments (+1.6%). Janus Electric (JNS, +0.9%, see below), cryopreservation technology company, Vitrafy (VFY, +0.2%), mental health innovator, Emyria (EMD, +0.2%) and tin explorer, Caspin (CPN, +0.2%) were strong performers.

M&A (-0.2%) was muted as large positions, SDI (+0.01%) and Clearview (CVW, flat), reached completion. There is a deep pool of non-binding takeover offers in the market currently. We are monitoring for updates and potential investments once binding.

Positive screen fundraising case study – Janus Electric (JNS, +0.9%)

JNS is a leader in heavy vehicle electrification. The Fund participated in their May-26 equity placement. Since that time JNS has announced multiple material contracts in the US. The company harnessed this momentum to carry out a further equity placement in Jul-26 to assist in funding infrastructure, customer support and delivery for the North American market.

The Fund is open for investment with applications processed at the end of each month.
